1. COURSE DESCRIPTION/OVERVIEW

This course covers phonetics and phonology from both descriptive and theoretical perspectives. Students will acquire practical skills in phonetic transcription as well as with phonological analysis. This course's significance arises from the fact that pronunciation is considered to be one of the most important aspects of learning a language. This is because pronunciation errors may lead to confusion and total misunderstanding. These errors may be avoided when students learn the sounds of the language they are learning. This includes learning sounds in isolation as well as in connected speech.

2. COURSE OBJECTIVES

By the end of this course, students are expected to be able to:

- **A.** learn a number of technical terms related to the course.
- **B.** describe the production of English sounds.
- C. differentiate between consonants and vowels.
- **D.** pronounce English sounds in isolation and in connected speech.
- **E.** distinguish phonemes and allophones.
- **F.** know the structure of the English syllable.
- **G.** know the different types of stress in English.
- H. distinguish strong and weak forms.
- I. know the different intonation patterns of English

4. COURSE ASSIGNMENTS/REQUIREMENTS

- **B.** Formal examinations: A mid-term and a final exam are required in this course.

5. COURSE PROCEDURES/CLASS POLECIES

Primary instructional modalities in this course are lecture and self-directed study, but a part of most class sessions will be devoted to participative learning. Active participation is the central requirement for the class. Effective participation requires preparation. It is crucial to come to class having carefully read and thought about the day's reading. To ensure a smooth flow of discussions, students are encouraged to listen with an open mind, respect the contributions of others, and avoid personal attacks. Students will often be faced with alternative viewpoints from the professor or their peers. Thus, students should be prepared to defend their own positions with empirical data, obtained from the assigned readings, and reasoned argument.

Plagiarism or academic dishonesty will have consequences from failure of the assignment or exam to failure of the entire course. Rest assured that I am an expert in tracing plagiarism using various computer programs and other resources and must and will treat all cases very seriously.

Any student missing class quizzes, examinations, or any other class work because of unexpected problems shall be given an opportunity during that semester to make up missed work.
